# SECURED Open Call Proposal Form

## Overview

This annex serves as a reference for applicants submitting proposals via the SECURED Open Call online portal. The proposal form is designed to capture essential information about the applicant and the proposed project. All fields marked with an asterisk (\*) are mandatory.

Applicants must ensure that all fields are completed and the required documents are uploaded in the correct format. Proposals submitted via the portal will undergo an eligibility check before proceeding to the evaluation phase.

Below is a detailed description of the fields in the **Proposal Submission Form** (available online at: <https://secured-project.eu/open-call-submission-form/> ).

## 1. Applicant Details

### Type of Applicant\*

**Options:** Select whether the applicant is an organization, principal investigator, or an individual. This field helps categorize the type of applicant submitting the proposal.

### Applicant's Name\*

**Details:** Enter the name of the SME/organization/university (entity), the Principal Investigator's full name, or the individual applicant's full name.

This field ensures the proposal is linked to the appropriate entity or individual

### Applicant's Email\*

**Details:** Enter the email address of the entity's Principal Investigator or the individual applicant. All future communications regarding the Open Call will be sent to this email address.

### PIC Number / ORCID ID\*

**Details:** Enter the Participant Identification Code (PIC) for organizations or the ORCID ID for individual applicants. The PIC number uniquely identifies organizations (entities) in EU-funded projects, while the ORCID ID uniquely identifies individual researchers.

## 2. Proposal Metadata

### Title\*

**Details:** Provide the title of the project proposal. This should succinctly capture the essence of the proposed solution.

### **Description\***

**Character Limit:** Up to 1000 characters. Provide a brief description of the proposal, outlining the key objectives, the technology used (e.g., Secure Multiparty Computation, Homomorphic Encryption, etc.), and the expected impact on healthcare data analytics.

## **3. Proposal File**

### **Proposal File (PDF format only)\***

**File Format:** Upload a PDF file with a maximum size of **16 MB**.

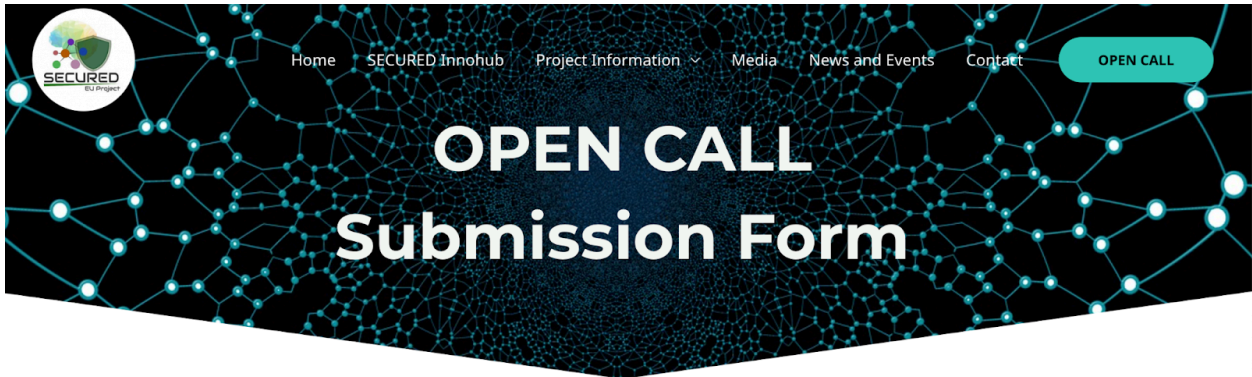
The proposal file must contain detailed information about the project, including a comprehensive description of the proposed solution, project plan, budget, and any additional documents required (technical proposal, etc.). The uploaded file must adhere to the guidelines and templates provided in **Annex 2 - Guidelines for Applicants** and **Annex 2.1 - Technical Proposal Template**.

### **Submission Notes:**

- **File Naming Convention:** Ensure that the uploaded PDF file follows the naming convention specified in the guidelines (e.g., 'SECURED\_ProjectName\_ApplicantName.pdf');
- **Submission Deadline:** Proposals must be submitted by **31 October 2024, 17:00 CET**. Late submissions will not be accepted;
- **Technical Assistance:** If applicants encounter technical issues during the submission process, they should contact the SECURED Open Call support team at **secured-open-call@list.uva.nl**.

### **Important Notes for Applicants:**

- All information provided must be accurate and up-to-date;
- Ensure that the proposal meets the eligibility criteria outlined in **Annex 2 - Guidelines for Applicants**;
- Review all details carefully before submitting, as modifications cannot be made after submission;
